Terms and Conditions

1. All purchases of Qualifying Products as identified here and invoiced during 1st July 2018 to 31st January 2019 will count towards the Qualifying Target of 5000 points. Upon achieving at least 100% of the Qualifying Target the Customer will qualify for two places (sharing a twin / double room) at the designated hotel in Las Vegas between 20th and 24th May 2019 ("the Reward"). A maximum of two places sharing one twin / double room can be claimed.
2. The Reward includes return economy flights from London to Las Vegas, four nights' accommodation at the designated hotel in Las Vegas including transfers.
3. The Reward does not include travel insurance. Travel costs incurred in reaching the point of departure, extras or resort fee supplements are the responsibility of the Customer.
4. All incidental costs (including all non-complimentary alcoholic and non-alcoholic beverages) incurred by Participants at the hotel, not included in the Reward, will be the Customer's responsibility and accounts must be settled in full prior to their departure from the hotel.
5. Customers must confirm to the Company in writing, by 28th February 2019, the full names of the Participants from the Company attending the Reward. The Reward cannot be transferred from the individuals named to any third parties.
6. The total value of the Reward to Participants is estimated to be approximately £2,000 per person or £3,000 per couple. Individual Participants, and their travelling companions, could incur a tax liability dependent on their employment status. The reporting of the Reward to the HMRC and any tax liability and / or National Insurance contributions arising from it is the responsibility of the individual, and the Customer, concerned as appropriate.
7. No Reward will be given if the Qualifying Target is not met within the Qualifying Period. Customers that have qualified will be advised in writing by 8th February 2019 that they have achieved their Qualifying Target.
8. The Company reserves the right to withhold the Reward from Customers whose accounts are not settled within the agreed credit terms during the Qualifying Period or whose accounts are in arrears or default at the time the Reward trip takes place. Credit notes issued relating to invoices issued during the Qualifying Period will be deducted when calculating if the Qualifying Target has been met.
9. The Company reserves the right to amend the Las Vegas Promotional Reward without notice.
10. No alternative award (cash or otherwise) will be offered under any circumstances.
11. Registration Forms must be completed and signed by a Director or Proprietor who is authorised to sign on behalf of the Customer and returned to the Company. Incomplete or unsigned Registration Forms shall be void and render the Customer ineligible to claim the Reward. Only bona fide Flooring Contractors over the age of 21 years can take part in the promotion.
